2.1	<ul> <li>Public Open Forum Session. Members of the public are invited to address the Council for a maximum of 20 minutes with any individual contribution lasting up to 3 mins. Representations shall not require a response at the meeting nor start a debate.</li> <li>Two members of the public in attendance to address the Council regarding parking and speeding in the village.</li> <li>Concerns raised regarding the poor and dangerous parking during school pick up and drop off times. Blocked pavements, drop curbs and parking on corners. Resident aware PCSO has asked for photos of offending cars to be taken and sent to her, but the residents do not want to put themselves at risk doing this, Resident suggested sending a copy of the KK to all parents at the school so they can read Council's repeated requests to park considerably. Resident concerned there are accidents waiting to happen and the issue will only get worse if develop on edge of the village goes ahead. Agreed matter would be discussed further at the January meeting as Councillors have a meeting with highways next week to discuss parking and speeding.</li> <li>Resident raised speeding in and around the village and stated he was of the view that the Council needed a clear strategy to deal with the issue of speeding. One suggestion was that delivery companies be written to directly to remind staff they should be driving according to speed limits when driving in their work capacity. 	speed limits when driving in their work capacity. Cllr Nicholls acknowledged that there is a problem with speeding but advised that the PC regularly raise the matter with Highways and try to find solutions to it.

Update received. Council, contractors and village hall have worked together to agree that the village hall car park can be used while work being undertaken. Council considered the use of the grass space to the left of the village hall to be used for further parking if matting was installed. Council discussed and agreed they did not want this area to be used for parking by the contractors or going forward.</li> </ul>

	<ul> <li>Village sign: Cllr Haycock was not in attendance, as she was gathering information for this project. Council were of the view this should be considered at the next meeting when she was in attendance.</li> <li>Streetlighting: Council considered the installation of lighting on the REC. After it was discussed Council agreed a light would not be appropriate in the REC as there was a bylaw that the REC was for use in daylight hours. In theory the REC could be locked in the evenings although this was not done in practice.</li> <li>Cycle and Pathways: Council received an update. A meeting of the working party is taking place on 19<sup>th</sup> November 2025.</li> <li>Resident email: Concerns raised regarding school parking and suggestion to approach the school and PCSO regarding the matter. Council discussed and agreed to write to the school to ask them to forward the letter to all parents highlighting the problems. The matter of parking and speeding will be discussed at the meeting with WNC highways.</li> <li>Butts Lane: Update received, the path has now been finished and tree works will be undertaken this month.</li> </ul>
